- On January 30, 2009, the Annuity Trust of which the Reporting Person is a trustee and a beneficiary distributed to the Reporting Person annuity payments ("Annuity Payments") in the form of the assignment of a portion of the options held by the Annuity Trust in satisfaction of the Annuity Trust's obligations to pay such Annuity Payments to the Reporting Person.
- On February 28, 2009, the Reporting Person rolled the portion of the options that the Reporting Person received in satisfaction of the Reporting Person's Annuity Payments into a second series of Annuity Trusts.
- On May 31, 2009, the Reporting Person contributed an option to purchase 5,000 shares of the Company's Common Stock to the Frank J. Biondi, Jr. Annuity Trust No. 26 of which the Reporting Person is the trustee and a beneficiary.
